Classification - Attaining prescribed age of 60 /80 years on 31st March itself, in case of senior/city senior citizens whose date of birth falls on 1st April

-Set-off of losses not permissible against unexplained income, investments, money etc. chargeable under sections 68/69/69A/69B/69C/69D

Certain cases when income of a previous year will be assessed in the previous year itself:

- Shipping business of non-resident
- Persons leaving India
- AOP / BOI / Artificial Juridical Person formed for a particular event or purpose
- Persons likely to transfer property to avoid tax
- Discontinued business

Residential Status & Scope of Total Income

A) RESIDENTIAL STATUS OF AN INDIVIDUAL:

Resident:

if he fulfils any one of the following two basic conditions [Section 6(1)]

- 1) He is in India in that year for a period or periods amounting in all to 182 days or more OR
- 2) 60 days or more during the previous year and 365 days or more during the 4 years immediately preceding that previous year.

Exception I [Explanation to Sec. 6(1)]

In the case of following special individuals, the 2nd basic condition is not applicable:

- 1) who leaves India for the purpose of employment outside India or
- 2) An Indian Citizen who leaves India during the previous year as a member of the crew of an Indian ship
- 3) An Indian Citizen or a person of Indian Origin, who comes on a visit to India during the previous year.

Determining the period of stay in India for an Indian citizen, being a crew member of foreign bound ship:
Period to be excluded from income date entered in Continuous Discharge Certificate
Te-leave off date entered in Continuous Discharge Certificate

Resident and Ordinarily Resident:

In addition to fulfilling one of the above basic conditions, the individual shall have to fulfil both the following additional conditions for him to be considered as resident and ordinarily resident [Section 6(6)]

- 1) He has been resident in India in at least 2 out of 10 years preceding the relevant previous year

- 2) He has been in India for a period of 730 days or more during 7 years preceding the relevant previous year.

RESIDENTIAL STATUS OF H.U.F. : [Section 6(2)]

Resident: A Hindu Undivided Family is said to be resident in India, if control and management of its affairs is wholly or partly situated in India.

Non-resident

A Hindu Undivided Family is non-resident in India, if control and management of its affairs is wholly situated outside India.

Resident and Ordinarily Resident:

A resident H.U.F. will be treated as Resident and Ordinarily Resident only if its Karta (or manager) has satisfied the two additional conditions of Sec. 6(6)
