In late August 2003, based on metrocological forecasts from the Bed Cross-Bed Cressent Climate Genter and other sources, and in anticipation of sevene humanitarian need, the ICBC took the decision to pivot the Soundia programme to propers for and respond to expected extreme flooding caused by El Hitlo. Existing activities in the south of Soundia were put on hold and the Delegation refocus on expected sixuation flooding along the Shehelle and Jube rivers in October. This is the first instance of the ICBC undersalting an Anticipatory Action bosed approach at a whole at delegation level, using scientific climest data to setticipate, propert for and respond to humanitudies criter at scale shoul of dissener settleing.
