a. HOMOLOGOUS STRUCTURES

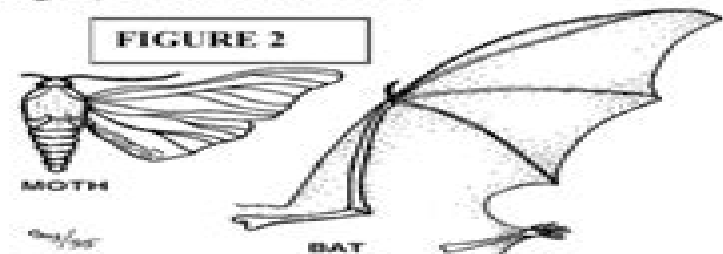
