Throughout this document the term behavioral health encompasses both mental and substance use disorders. When a mental or substance use disorder is addressed singularly the reference will be only to that disorder. Because each state's Medicaid program is different from all others and because Medicaid laws and policies are ever changing this handbook cannot contemplate every permutation of program construction.

Crisis Services: Effectiveness, Cost-Effectiveness, and Funding Strategies U.S. Department of Health and Human Services, 2019-11-23 Crisis Services are a continuum of services that are provided to individuals experiencing a psychiatric emergency. The primary goal of these services is to stabilize and improve psychological symptoms of distress and to engage individuals in an appropriate treatment service to address the problem that led to the crisis. Core crisis services include 23 hour crisis stabilization observation beds, short term crisis residential services, and crisis stabilization mobile crisis services, 24/7 crisis hotlines, warm lines, psychiatric advance directive statements, and peer crisis services. The research base on the effectiveness of crisis services is growing. There is evidence that crisis stabilization, community based residential crisis care, and mobile crisis services can divert individuals from unnecessary hospitalizations and ensure the least restrictive treatment option is available to people experiencing behavioral health crises.
