This opportunity includes the matching contribution if you are over the age of 50 as any time during 2018. As before, you enroll for your 2018 benefit coverage. If not, you can increase your contributions with a simple check off the menu.

As an added bonus, because Forgie takes about 10 minutes to enroll, you can increase your contributions to their 401(k) plan.

Eligible employees start with 7% of eligible pay up to \$1,000.

After five years of service, you will receive 2% of eligible pay up to \$1,000.

Contributions will be made in the first quarter of the following year.

The automatic contribution is made to all eligible employees, regardless of their contribution to the plan or not.

For example, if you have been with the company for five years and make \$40,000, you will automatically receive 7% in your 401(k).



### Eligibility

In order to be eligible for The Forgie Co. 401(k) plan, you must be 21 years old and have 90 days of service. Once you have completed 1,000 hours of service during a 12-month period, you can receive the employer-matching and automatic contributions.
