Abstract

- Receipts are required regardless of the dollar amount, even for as little as a \$1 contribution.
- Contribution amounts of less than \$250 and made to a charitable organization, is bank record or a computer check/card statement; or a written acknowledgement from the charity is needed.
- Contribution amounts of more than \$250 and to a charitable organization, you must have both a bank record and a written acknowledgement from the charity.

- Deduction of less than \$2500 - A receipt or a written acknowledgment from the charity.
- Deduction between \$250 and \$5000 - A written acknowledgment by the charitable organization.
- Deduction between \$500 and \$5,000 - Same records required as the \$250 to \$500 category. In addition, records must show how the property was acquired, the date acquired and the adjusted basis of the property.
- Deduction of more than \$5,000 - Same records required as the \$500 to \$5,000 category. In addition, records must include a written appraisal.

To begin, a substantial deduction for the fair market value of used items donated to charity makes a list of such items donated on a separate sheet of paper along with the following:

- Name and address of charity.
- Date items were donated to the charity.
- Descriptions of each item donated.
- Fair market value of each item at the time they were donated (see the following list).
- Date each donated item was originally purchased or acquired.
- Cost or other basis of each item donated.
- Name report to be in record retention or further.
