3. Income includes loss
4. Assessee includes person who has to receive refund from income tax department.
5. Tax rates are fixed by the annual Finance Act and not by the Income tax Act.
6. If on the first day of April of the assessment year, the new Finance Bill has not been placed on the statute book, the provisions in force in the preceding assessment year or provisions proposed in the Finance Bill before Parliament, whichever is more beneficial to the assessee, will apply until the new provisions become effective.
7. For arriving at the total income of the assessment year 2008-09 provisions of the Income tax Act as on April 1, 2008 are applicable. Any
