



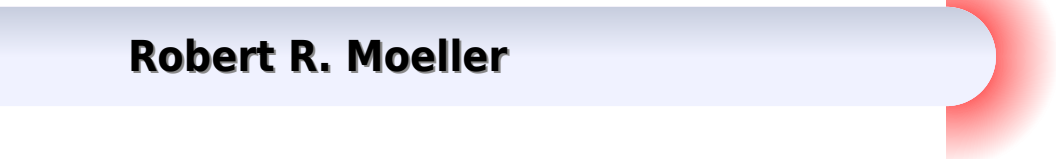
HIPAA - Policy
