Project fee shall be a flat fee. Expense reimbursement is allowed only if all criteria are met on the Independent Contractor Travel Expense Reimbursement Checklist.

The project fees applicable to this agreement are as follows:

Article II – Term of Agreement

- 2.1 The term of this Agreement shall be only for such period of time as required for Contractor to perform the services described in Article I or until Client notifies Contractor that this Agreement has ended.

Article III – Terms of Payment

- 3.1 Contractor shall be paid on a per project basis pursuant to the fee schedule set forth in Article I. To facilitate payment Contractor shall submit an invoice for services. Contractor must submit a tax identification number to Client as a condition of payment.
