The question of whether the federal government can compel a manufacturer to provide access to a locked electronic device was hotly debated and ultimately unresolved in two recent cases that the government voluntarily dismissed. Hilger, the Seventh Circuit U.S. Court of Appeals is considering whether an insurer is permitted to conduct discovery to determine whether a party is an insured when there is purportedly a strong reason to believe otherwise. The Texas Supreme Court in Paxton v. City of Dallas will decide whether untimely assertion of the attorney-client privilege can satisfy a 'compelling reason' burden and rebut a presumption that information held by the government is open to the public.

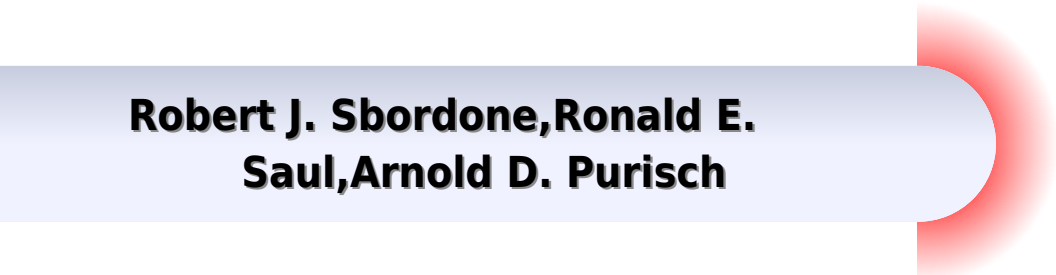
