Chapter 1 - Financial Accounting

- Accounting to accumulate, record, and report financial information that is useful to decision makers
- Internal Decision Makers people inside the company that use internal information to make decisions for the company (managers, CEO, CFO, head of division)
- External Decision Makers people outside the company who figure out if they should invest or lend money to a company, using financial information provided by accounting

Differences between Financial and Managerial Accounting

Financial

 External persons who make financial decision, historical perspective, emphasis on objectivity and verifiability, emphasis on precision, focuses on companywide reports, must follow GAAP/IFRS and prescribed formats, mandatory for external reports

Managerial

 Managers who plan and control organization, future emphasis, emphasis on relevance, focus on segment reports, not mandatory for external reports

Assets - what the company owns

Liabilities - what the company owes

- listed in terms of maturity (how soon an obligation must be paid)

Owners' Equity - ownership investments in the company and income retained by the company Revenue - inflows (income) from selling goods or services

Expenses - outflows (costs) from operating the business

Net Income - how much a company earns during a time period (income - costs)

Accounts Receivable - money other companies owe for a short period of time

Notes Receivable - money other companies owe for a longer period of time

Four Basic Financial Statements

- Balance Sheet reports the financial position (amount of assets, liabilities, and stockholders' equity) of a company
- Income Statement reports of the revenue less the expenses during the accounting period
- Statement of Stockholders' Equity reports of the changes in each of the company's stockholders' equity accounts
- 4. Statement of Cashflow reports of inflows and outflows
