As a result of the trisections,

isosceles  $\triangle AHD \cong$  isosceles  $\triangle BFC$ , and



isosceles  $\triangle AGB \cong$  isosceles  $\triangle DEC$  (Fig. S1-14a).

Since  $AH = HD = FB = FC$ , and  $AG = GB = DE = CE$ ,

and  $\angle HAG \cong \angle GBF \cong \angle FCE \cong \angle HDE \cong \frac{1}{3}$  right angle,

$\triangle HAG \cong \triangle FBG \cong \triangle FCE \cong \triangle HDE$  (S.A.S.).

Therefore,  $HG = FG = FE = HE$ , and  $EFGH$  is a rhombus (#21-I).



**Challenge 1** What type of quadrilateral would be formed if the original rectangle were replaced by a square?

Consider  $ABCD$  to be a square (Fig. S1-14b). All of the above still holds true; thus we still maintain a rhombus.

However, we now can easily show  $\triangle AHG$  to be isosceles,  $m\angle AGH = m\angle AHG = 75$ .

Similarly,  $m\angle BGF = 75$ .  $m\angle AGB = 120$ , since  $m\angle GAB = m\angle GBA = 30$ .

Therefore,  $m\angle HGF = 90$ . We now have a rhombus with one right angle; hence, a square.

**1-15** In Fig. S1-15,  $\overline{BE}$  and  $\overline{AD}$  are altitudes of  $\triangle ABC$ .  $F$ ,  $G$ , and  $K$  are midpoints of  $\overline{AH}$ ,  $\overline{AB}$ , and  $\overline{BC}$ , respectively. Prove that  $\angle FGK$  is a right angle.

In  $\triangle AHB$ ,  $\overline{GF} \parallel \overline{BH}$  (#26).

And in  $\triangle ABC$ ,  $\overline{GK} \parallel \overline{AC}$  (#26).

Since  $\overline{BE} \perp \overline{AC}$ ,  $\overline{BE} \perp \overline{GK}$ ,

then  $\overline{GF} \perp \overline{GK}$  (#10); that is,  $\angle FGK$  is a right angle.
