- In-text Referencing: involves citing references within the text of your work where you have used ideas or material from other sources.
- End-text referencing (also known as your Reference List): includes all materials used in your document. It
  provides the full information of reference sources necessary for a reader to locate and retrieve them.

**IMPORTANT NOTE:** When writing your reference list, do not present them in different section based on the types of information sources. All sources of information must be presenting in a <u>single list in ascending alphabetical order</u>.
