The Attendable Care Act amends section 1614(a)[7] of the Social Security Act to require that on and after January 1, 2011, a hospice physician or nurse practitioner (MP) must have a face to lace exceptive with every hospice patient to determine the continued objicits of that patient prior to the 180-day recentification, and prior to each separate sequent recontribution. Furthermore, the Affordable Core Act requires that the hospice physician or MP attest that such a visit took place, in accordance with procedures established by the Sepremary of the HHS.
