remedies so as to deprive the district court of subject matter jurisdiction *Brown v Snow* 440 F 3d 1259 11th Cir 2006 A majority of states impose a shorter period for filing with their agencies though so the filing deadline is not always extended when a state has its own agency The "single filing rule" under which a party who has not filed an EEOC charge or received a right to sue notice may "piggyback" his or her judicial action on the claim of a party who has satisfied those prerequisites has been described as a "carefully limited exception" to Title VII's procedural requirements *Price v Choctaw Glove and Safety Co* 459 F 3d 595 5th Cir 2006 Provided that an act contributing to the claim occurs within the filing period the court may consider the entire period of the hostile environment for purposes of determining liability *Jordan v City of Cleveland* 464 F 3d 584 6th Cir 2006 The Supreme Court has held that a plaintiff's timely filing of an EEOC intake questionnaire which was followed by an affidavit stating "Please force Federal Express to end their age discrimination" constituted a charge cautioning however that its permissiveness
