A mammogram scans breast tissue for tumors or other abnormalities. It is typically performed for the first time when a woman is between 40 and 50 years old, and repeated every 1 to 2 years.

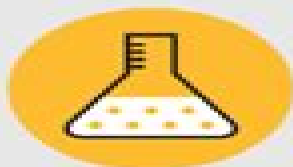

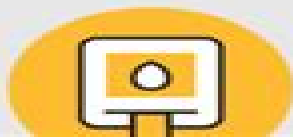
Blood test
