- Q1.1. Organizations undertake planning activities that support three major activities: financing, investing, and operating. Financing is the activity in which a company raises the cash for operations. Investing refers to the buying and selling of investments, representing the future and the organization's plans. Operating activities are the actual carrying out of these plans. Planning is the plan that coordinates these activities, including the organization's assets, goals, and strategies. Financial accounting information provides valuable input into the planning process, and, subsequently, reports on the results of plans and the company's activities over the future, if necessary.
- Q1.2. An organization's financing activities (debt and equity) is sources of funds to pay the investing activities (assets) or return of funds. An organization's assets cannot be more or less than the liabilities and equity combined. This means: $\text{assets} = \text{liabilities} + \text{equity}$. This relation is called the accounting equation (statement called the balance sheet equation), and it applies for all organizations at all times.
