- **Concurrent Jurisdiction:** Both Federal and State Courts can hear a case when both Federal and State Law was broken.
- **Original Jurisdiction:** the authority to hear the case first. All Federal cases must start in Federal District Courts.
- **Appellate Jurisdiction:** the authority to hear a case that has been appealed from a lower court.
- **Appeal:** request the decision of a lower court be reviewed
- **Remanding:** send a case back to a lower court to be heard again as part of an appeal process.
- **Opinion:** a detailed legal explanation of a court's decision.
- **Precedent:** a model of a similar court decision used as guidance in the decision making of the court.
