Money Claim Online (MCOL) – User Guide for Claimants

Why should I read this information?

MCOL is designed to be a relatively simple way to issue a county court claim for a fixed amount of money. However, errors made can be costly to you both in time and money and may affect the outcome of your claim. It is important to note that if you make an error upon issue of the claim you will not be eligible for a refund of the court fee.

This guidance should help you to:

- ensure that the claim you issue is suitable for MCOL
- understand your role and responsibilities during the claim process
- understand the role of the court in the claim process

Important information: This information is only intended as a guide. You may wish to seek assistance from a solicitor or local Citizens Advice Bureau.

A number of sections of the user guide may make reference to relevant legislation. There is no attempt within the user guide to interpret specific legislation, but where statutory requirements exist, these naturally take precedence over the user guide.
