

- Vertical restraints = agreements or concerted practices entered into between two or more companies each of which operates, for the purposes of the agreement, at a different level of the production or distribution chain, and relating to the conditions under which the parties may purchase, sell or resell certain goods or services.
- Vertical restraints are generally less harmful than horizontal restraints and may provide substantial scope for efficiencies.
- In most cases, competition concerns can only arise if there is insufficient competition at one or more levels of trade.
