

# HIPAA Compliance Policy

## 1. Purpose

This HIPAA Compliance Policy is designed to ensure that [Organization Name] adheres to the requirements of the Health Insurance Portability and Accountability Act (HIPAA) of 1996 and the subsequent amendments, including the Health Information Technology for Economic and Clinical Health (HITECH) Act. To protect ePHI, [Organization Name] implements the following security measures:

- **Administrative Safeguards:** Policies and procedures designed to clearly show how the entity will comply with the act.

- **Technical Safeguards:** Automated processes used to protect data and control access to data.
