RULE: DOUBLE THE FINAL CONSONANT WHEN THERE IS ONE SHORT-VOWEL + ONE FINAL CONSONANT, THEN ADD THE ENDING (-ER, -ED, -EST, -ING)

EXAMPLES:

win *or* winning, winner
big *or* bigger, biggest
rub *or* rubbing, rubber, rubbed
hop *or* hopping, hopper, hopped
tap *or* tapping, tapper, tapped
mad *or* madder, maddest
glad *or* gladder, gladdest
drip *or* dripping, dripper, dripped
plan *or* planning, planner, planned
trim *or* trimming, trimmer, trimmed
swim *or* swimming, swimmer

Doubling Rule

- One vowel
- One final consonant
- One accent
- Vowel suffix (ing, er, ed)

Example:

- stop + ing = stop**ping**
- win + er = win**ner**
- plug + ed = plug**ged**

Step:

- Write the root word
- Double the final consonant
- Add the suffix
