**IN RE: AMENDMENTS TO RULE REGULATING THE FLORIDA
BAR 5-1.1(g)**

June 18, 2021

PER CURIAM.

The Task Force on the Distribution of DOTA Funds (Task Force) petitions the Court to amend rule 5-1.1(g) (Trust Accounts; Interest on Trust Accounts (DOTA) Program) of the Rules Regulating the Florida Bar (Bar Rules). We have jurisdiction. See art. V, § 15, Fla. Const. With the substantial modifications discussed below, we adopt the amendments to rule 5-1.1(g) proposed by the Task Force.

BACKGROUND

In 1978, this Court adopted the nation's first Interest on Trust Accounts Program. *In re Interest on Trust Accounts*, 356 So. 2d 799 (Fla. 1978). The program became fully operational in 1981, see *re Interest on Trust Accounts*, 402 So. 2d 389 (Fla. 1981), and
