

On 16 October 2013 the European Commission released its annual reports on prospective member states which concluded that the Albanian election was held in an "orderly manner" and that progress had been made in meeting other conditions and as such recommended granting Albania candidate status. A decision on making Albania a candidate is expected to be made at the European Council in December 2013



On 1 January 2008 the visa facilitation and readmission agreements between Albania and the EU entered into force. Albania received a road map from the EU for further visa liberalisation with Schengen countries in June 2008. On 8 November 2010 the Council of the European Union approved visa-free travel to the EU for citizens of Albania. The decision entered into force on 15 December 2010.
