- False documents to get loan
- Hiding any property or its true value
- Offering false contact information
- Disposing any property secretly
- Taking debt with no intention to payback
- Giving preferential treatment to any creditor
- Applying for a loan without prior notice

CIVIL BANKRUPTCY FRAUD

When any creditor complains about any wrongdoing for a debt

CRIMINAL BANKRUPTCY FRAUD

When a complaint involves many creditors, it could lead to criminal bankruptcy fraud

HOW IT IS REVEALED?

- Trustees can ask questions regarding assets that the bankrupt disposes of, sells, or give
- Sworn statements detailing the affairs of the bankrupt person regarding their income, expenses, and debts
- Statement of Affairs
- Information from the neighbours, family, creditors, and banks

IF YOU'RE FOUND GUILTY

- No longer be eligible for bankruptcy filing
- fine or even get jail time
