On ... Mr. Reyes , the complainant in this case, decided to purchase the lot of Mr. X . The latter agreed to sell the subject lot to the complainant under a specific amount. The complainant was able to pay the said amount which lead to the transfer of the Deed of Sale (Annex B) of the said lot under the name of the complainant. Thus, since the complainant wanted to build a house on that lot , he first secure a construction permit. In consonance with this, he also need first to secure a plan for the building of his house. **However**, the controversy arose from the time that the **personnel** of the subdivision surveyed the lot. The complainant learned that his purchased lot with a total area of . was encroached by Mr. A's lot who happens to be the owner of another lot next to his lot. I response to this, Mr. A's contended that the construction of his house is within the area based on the survey made by Sta. Lucia Subdivision.

On ... Sta. Lucia made a re-survey of the lot of the complainant. However, upon adjustment of his lot, it will now occupy a portion of the side walk on their street. Thus, Sta. lucia Subdivision offered a remedy to just refund the value of the portion that was occupied by the lot of Mr. A but based on the fair market value of the lot from the time that Mr. X bought the lot and not based on the current fair market value of the lot. In response to this, the complainant wanted to obtain a refund not only based on the portion that was occupied by Mr. A's house but also the whole side of the portion of his lot in order to have a good lot proportion.
