choice 2 works because when n=1, which represents the first day, we get $a_1 = 90 + 30 \cdot (1)$ which equals 120 minutes or two hours as stated. when n=2, which is the second day, we get $a_2 = 90 + 30 \cdot (2)$ which equals 150 minutes or 2.5 hours
