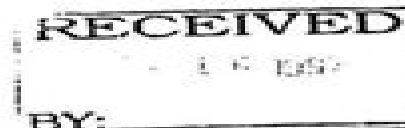

Describe victim's injuries and location of injuries

The victim is reported to have been shot in the right upper arm/shoulder area and the right temple area. The victim had been transported prior to the arrival of reporting officer. The victim could not be interviewed at the Hospital as he was in surgery.

Describe Location and place of occurrence (ie: residence, vehicle, outdoors, business, etc)

The scene is a single story wood frame residence with attached single car garage and full unfinished basement. The residence is painted white with brown trim. The residence faces South with a centrally located front door and a front entry overhead garage door. A rear entry door is positioned on the North side of the garage with access to the residence from the garage to the kitchen by means of a double hung door. The residence is neighbored on the South, West and East by similar residences. A wooded area and field are located to the North side of the residence and separate the residence from a gas station / convenience store.

The victim reported arriving home from work to discover a black male subject in his bedroom. This subject is reported to have shot the victim twice then fled the scene when the victim telephoned Ofallon Police.

Three casement type windows are positioned in the Northwest corner of the concrete foundation. The screen frame and glass pane frames are removed from the North most window creating an opening 30" x 16". The two frames are lying on the ground West of the residence. These frames are bent and the glass panes are broken. Glass shards and larger pieces of glass are observed on the interior and exterior of the residence. The immediate area of the window is void of snow. Snow covers the ground on the West and North sides of the residence. The external temperature is recorded at 12 degree. Several shoe impressions of a waffle type sole are located in the snow near the residence and in the rear yard. St. Charles City Police K-9 unit attempted to track these shoe impressions with negative results. No exact size of the impressions could be determined. The window frames were seized for later fingerprint processing.

A white plastic Shop & Save grocery bag was observed on the ground near the basement window. The bag was seized and discovered to contain the following property.
