 - lawsuit that is brought on behalf of multiple people
- l. **Fee shifting**
 - analyzing the casefile to send the court fees to the defendant if the plaintiff wins
- m. **Standing**
 - wanting to file a lawsuit (what constitutes a case + the harm has been done)
