1. Basic Finance Concepts
Q: What are the three main financial statements and how do they relate to each other?
A: The three main financial statements are the Income Statement, Balance Sheet, and Cash Flow Statement. The Income Statement shows a company's revenues, expenses, and profits over a period. The Balance Sheet shows a company's assets, liabilities, and shareholders' equity at a specific point in time. Instead you can use Revenue multiples EV Revenue Adjusted EBITDA multiples if the company has positive cash flow before interest taxes depreciation and amortization Asset based valuation particularly in distressed situations
