**Empowerment zone or enterprise community.** Interest on certain bonds issued to help qualified businesses finance qualified property located in an empowerment zone or enterprise community is tax exempt. Remember provided net gain from sale of publicly traded securities. You may be able to postpone reporting part or all of your capital gain from publicly traded securities sold after August 5, 1993, if you buy certain replacement property within 60 days of the sale and meet certain other requirements.
