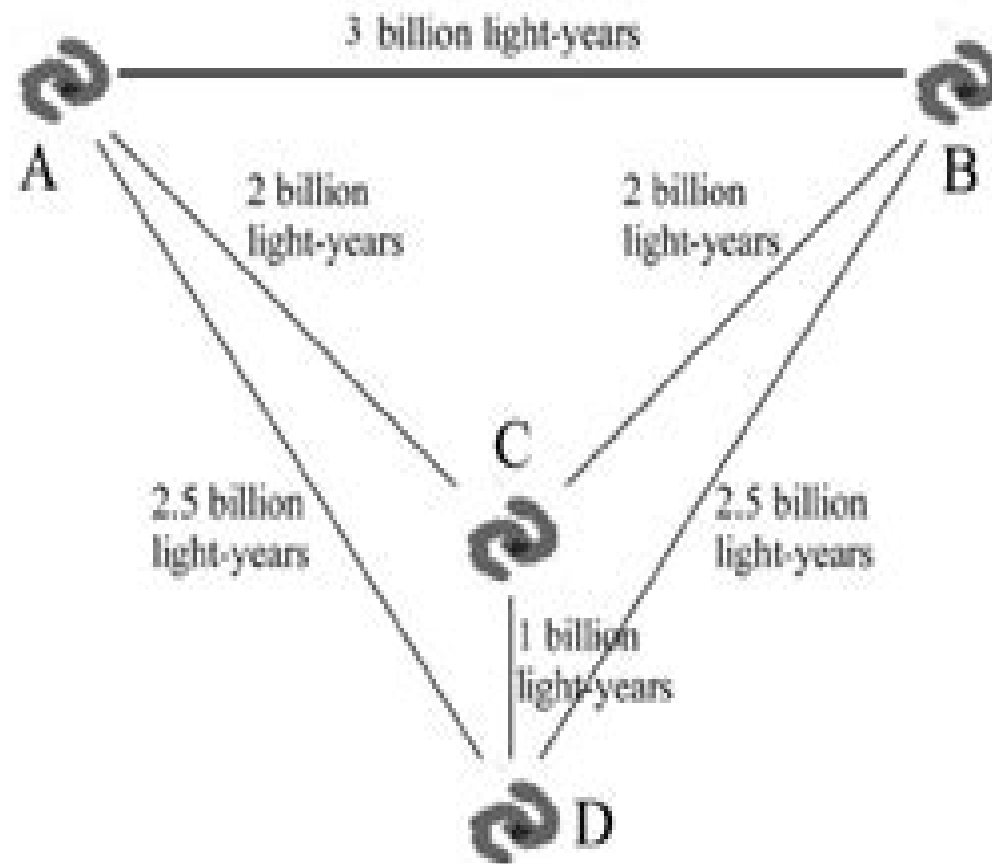


Consider the small section of the universe containing four galaxies (A-D), shown in the figure below. The distances between each galaxy are also shown.
