- For witnesses requires to provide a report,
  - A complete statement of the opinion and the basis and reasons for them
  - The facts or data considered by the witness
  - Any exhibits that support the opinion
  - The witness' qualifications, publications, prior testimony, and compensation
- Depositions permissible without Court order under F.R.Civ.Proc. 26(b)(4)
