Précis de droit pénal social Fabienne Kéfer, 2017-08-23 Les éditions Anthemis vous proposent un outil complet pour comprendre le droit pénal social. Peut-on expliquer le droit pénal social de la manière la plus simple et aux étudiants et aux professionnels ? Tel est le pari renouvelé de cette seconde édition devenue nécessaire après l'entrée en vigueur du Code pénal social. Comme dans la première édition, le choix et l'ordonnancement des chapitres ont été dictés par des préoccupations didactiques. Enfin, la responsabilité pénale de la personne morale. Les deux éditions 7 et 8 font un tour par des questions d'ordre civil : les responsabilités et immunités civiles des travailleurs et employeurs et la prescription de l'action pénale. Les neuvième et dixième éditions sont dédiées à la sanction pénale et administrative. Les questions de procédure pénale occupent les deux dernières éditions suivantes : les autorités de poursuite et les juridictions compétentes, la diversité et l'importance des pouvoirs des services de contrôle. Enfin, l'étude par le développement de trois incriminations particulières destinées à assurer l'effectivité des contrôles des services d'inspection du travail et spécialement celle d'obstacle à la surveillance. Le volume se termine par un index alphabétique, un lexique français-allemand et une table des matières dans les deux langues.
