- 3. Also on December 12, 2003 (by order entered December 17, 2003) the Court ordered Plaintiff to provide Defendant complete responses to the interrogatories propounded upon him on August 13, 2003 or face possible dismissal of his action.
- 4. On January 20, 2004 by the request of the Court, Defendant sent a letter to Plaintiff notifying him of the case management conference that was scheduled for January 26,
