Questions for Review and Discussion

1. The first criterion in financial accountability — the primary government either operates a voting majority of the unit's governing body, or a majority of the unit's governing body is composed of primary government officials and:
 - the primary government is able to prepare its own report on financial performance and/or
 - there is the potential for the government to generate specific financial benefits for its citizens separate from the benefits to the primary government.
2. Effective government is when one or both competing units are required to separate resources when those pertaining to the primary government. Separating is when the competing unit's resources are isolated and reported as if they were part of the primary government — that is, the competing unit's funds are accounted for just as if they were funds of the primary government. Separating is required when the primary government and the competing unit are controlled by governing bodies sharing the same members or the competing unit provides services solely to the primary government. If these conditions are not satisfied then effective government is required.
3. Effective government, as it must be applied to government-wide accounts, allows for the aggregation of one number of different independent units, irrespective of type and basis of accounting. Therefore, it is said, the government is evenly aggregated regardless of basis used. This problem is mitigated by the requirement of footnote 10, so that the government provide detailed financial information about each of its major component units.
4. The three main sections of the C.A.R.B. are:
 - mandatory section
 - financial section
 - statistical section

The main components of the financial section are:

 - auditor's report
 - management's discussion and analysis (MD&A)
