Surges and sudden stops in capital flow also constrained policy. But the three factors that cause a loss of monetary autonomy—governments, markets, and openness—moderate each other. Markets moderate fiscal profligacy, and global crises moderate market freedoms, and ensure openness remains a sequenced and gradual process.
