When does the claim code on the employee's federal TD1 have to match the claim code on the provincial/territorial TD1 - When a non-resident employee has a claim code of 0 on their federal TD1.

Applicable provincial/territorial tax rate: the employee works at the employer's premises - The province/territory where the premises is located.

Applicable provincial/territorial tax rate: the employee does not work at the employer's premises - The province/territory of the employer's office from which the employee is paid
