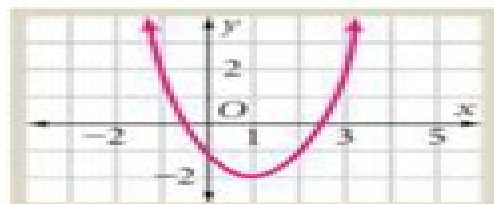

- The graph of a quadratic function is a U-shaped curve called a \_\_\_\_\_. The maximum or minimum point is called the \_\_\_\_\_.

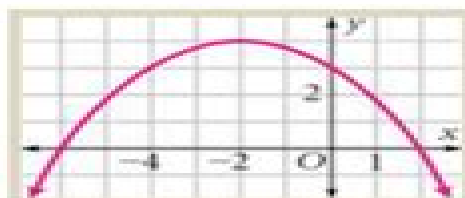

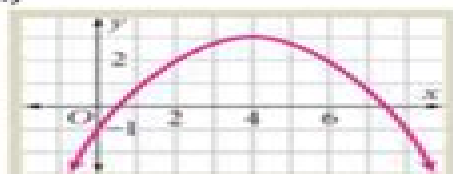

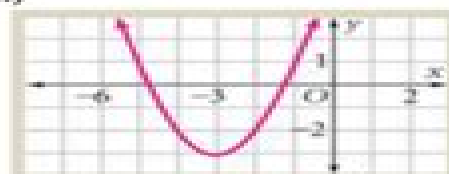

**B. Key Features of a Parabola:**

$$y = ax^2 + bx + c$$

- Direction of Opening:** When  $a > 0$ , the parabola opens \_\_\_\_\_;  
When  $a < 0$ , the parabola opens \_\_\_\_\_.
- Width:** When  $|a| < 1$ , the parabola is \_\_\_\_\_ than  $y = x^2$ .  
When  $|a| = 1$ , the parabola is the \_\_\_\_\_ width as  $y = x^2$ .

- Vertex:** The highest or lowest point of the parabola is called the vertex, which is on the axis of symmetry. To find the vertex, plug in  $x = \frac{-b}{2a}$  and solve for  $y$ . This yields a point (\_\_\_\_, \_\_\_\_).
- Axis of symmetry:** This is a vertical line passing through the vertex. Its equation is:  $x = \frac{-b}{2a}$ .
- x-intercepts:** are the 0, 1, or 2 points where the parabola crosses the x-axis. Plug in  $y = 0$  and solve for  $x$ .
- y-intercept:** is the point where the parabola crosses the y-axis. Plug in  $x = 0$  and solve for  $y$ .
