- Ensure proper documentation of patient requests.
- Staff Training
- Conduct regular HIPAA training for all staff.
- Maintain documentation of training sessions.

#### II. Security Rule Compliance

- Risk Assessment
- Regularly conduct risk assessments to identify vulnerabilities.
- Implement measures to address identified risks.
- Access Controls
- Restrict access to PHI based on job roles.
- Implement unique user IDs for staff.
- Data Encryption
- Encrypt electronic PHI during transmission and at rest.
- Ensure secure methods for PHI exchange.
