#### Valuation & Assumptions

Based on its due diligence and valuation estimates, Arrowhead believes that Voytur's fair share value lies in the CAD 1.42 to CAD 1.74 bracket, which has been calculated using a blended valuation method; with 50% weighting to a DCF method and 50% weighting to a Comparable Companies Valuation method. Our DCF model suggests a fair value of CAD 1.72, while a relative valuation provides a fair value of CAD 1.44.
