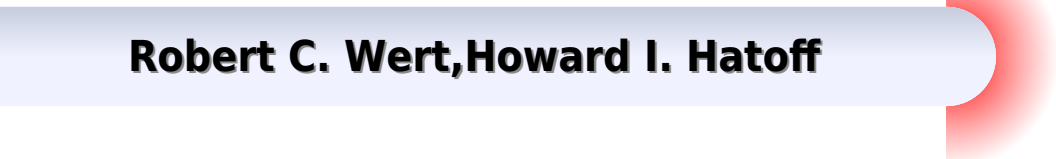
5. Security Measures
