$$(x + 3)(4x - 5) = 4x^{2} - 5x + 12x - 15 = 4x^{2} + 7x - 15$$

$$(\sqrt{a} + \sqrt{b})(\sqrt{a} - \sqrt{b}) = (\sqrt{a})^2 - \sqrt{a}\sqrt{b} + \sqrt{a}\sqrt{b} - (\sqrt{b})^2 = a - b$$

Or: Use the formula for the difference of two squares to see that  $(\sqrt{a} + \sqrt{b})(\sqrt{a} - \sqrt{b}) = (\sqrt{a})^2 - (\sqrt{b})^2 = a - b$

. Using it, we get  $(x + 2)^3 = x^3 + 3x^2(2) + 3x(2^2) + 2^3 = x^3 + 6x^2 + 12x + 8$ .

(b) Factoring by trial and error, we get 
$$2x^2 + 5x - 12 = (2x - 3)(x + 4)$$
.

(c) Using factoring by grouping and the difference of two squares formula, we have  

$$x^3 - 3x^2 - 4x + 12 = x^2(x-3) - 4(x-3) = (x^2 - 4)(x-3) = (x-2)(x+2)(x-3).$$

$$x^4 + 27x = x(x^3 + 27) = x(x + 3)(x^2 - 3x + 9)$$

This last expression was obtained using the sum of two cubes formula,  $a^a + b^b = (a + b)(a^2 - ab + b^2)$  with a = x and b = 3. [See Reference Page 1 in the textbook.]

 is  $-\frac{1}{2}$ , so we will factor out  $x^{-1/2}$ .
