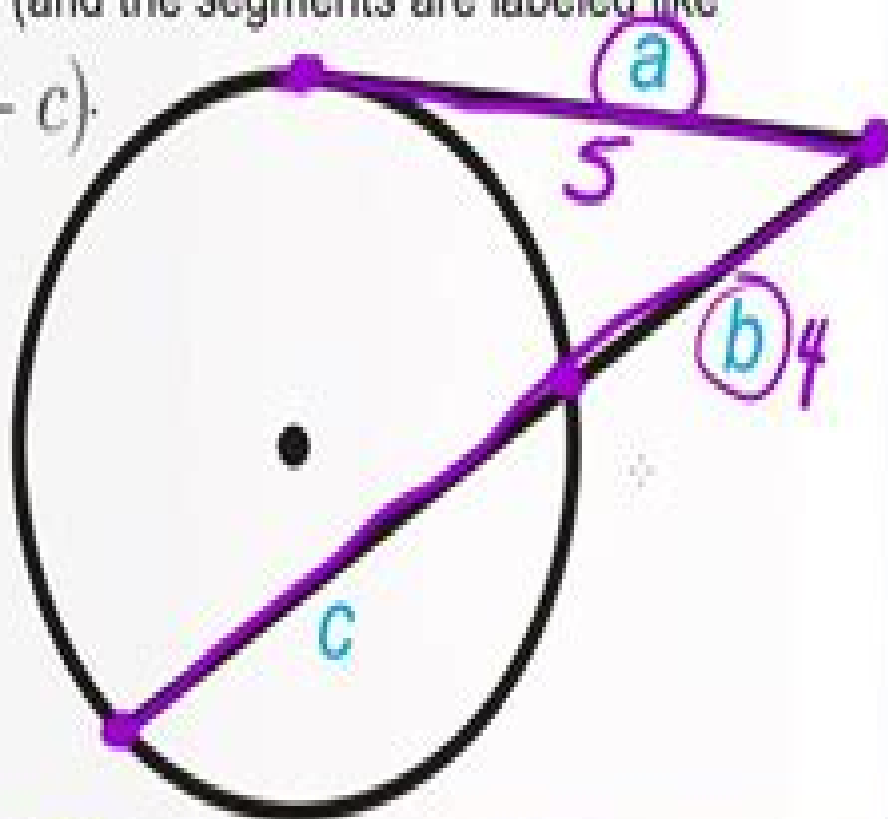


SEGMENTS FROM SECANTS AND TANGENTS
