IFRS (International Financial Reporting Standards) is a set of rules and guidelines that every firm has to adhere to ensure their financial statements are consistent with other firms worldwide.

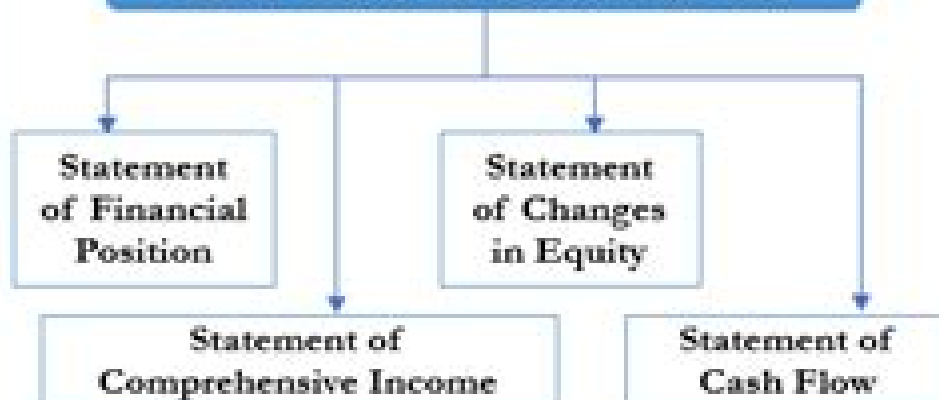

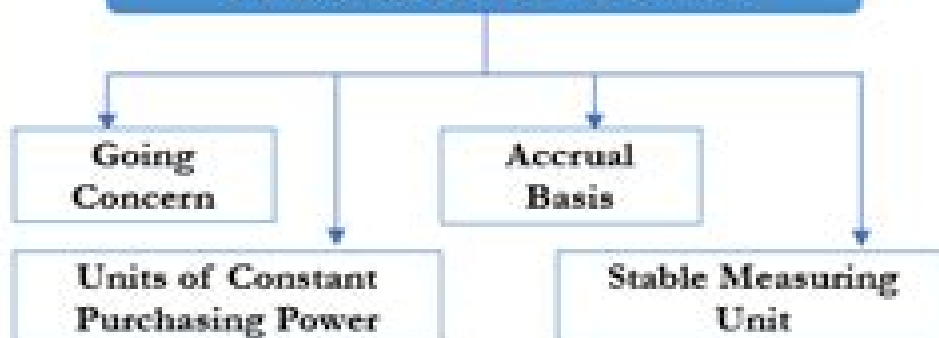
