- A good theory must give an adequate understanding of the subject it addresses.
- What does each theory tell us about law in a general sense?

AQUINAS

- *Summa Theologiae*, c. 12th century
- Begins with the nature of law in general.
- Law is a rule or measure of action in virtue of which one is lead to perform certain actions and is restrained from the performance of others.
 - o This is so because the very term which law is derived from comes from a Latin word meaning 'to bind'
- **The rule and measure of human action is reason.**
- It is reason that directs human action to its appropriate end
 - o All forms of human action are guided by reason
- *What is the relationship between law and reason?*
 - o Law is a form of human action – law has resulted from human action. It is either legislated or created judicially.
 - o If Reason is the rule and measure of human action, it is therefore the rule and measure of law.
 - o Reason directs law to its appropriate end.
