Sustaining China's Economic Growth After the Global Financial Crisis Nicholas R. Lardy, 2011-12-15 The global financial crisis and ensuing economic downturn has raised many questions concerning the future of global economic growth Prior to the financial crisis global growth was characterized by growing imbalances reflected primarily in large trade surpluses in China Japan Germany and the oil exporting countries and rapidly growing deficits primarily in the United States The global crisis raises the question of whether the previous growth model of low consumption high saving countries such as China is obsolete Although a strong and rapid policy response
