WITHIN THE PREMISES

- ❖ Please wipe the dining table dry after use. If needed, please sweep the floor for any fallen food crumbs.
- ❖ Practice **CLAYGO** or clean as you go. Your fellow boarders are not your personal house cleaners.
- ❖ Please throw your garbage in the proper garbage bin. Segregate your trash according to the labeled trash bins. Separate biodegradable from non-biodegradable trash.

WATER AND ELECTRICITY

- ❖ Please make sure to turn the faucets off after use.
- ❖ Please switch the lights off when not in use.
- ❖ Please unplug any appliances/chargers when not in use.
- ❖ Please unplug chargers before you sleep, avoid overnight charging that may cause overheating and may lead to fire.

LAUNDRY

- ❖ Washing of clothes are prohibited inside the comfort room. This is to allow other boarders to use the comfort room freely and immediately.
- ❖ Do the laundry in the water pump area.

KITCHEN

- ❖ If any, provided kitchen utensils are for general use thus you are required to wash it after use.

- ❖ Please keep all unused food properly sealed so you don't encourage pests such as mice and ants in the area.

- ❖ Please clean up after use. Remove fallen hair from blocking the drains on the sink or on the bathroom floor.
- ❖ Make sure that the faucet is properly switched off and that the water is not dripping. Please notify management immediately when there is a leak in the faucet.

- ❖ Switch off the lights when not in use.
