Contract is voidable for duress (duress is duress)

- One of the parties has imposed on the other party with force.
- The threat of force is sufficient to the threatened party's decision whether or not to enter into the contract.
- The threat must be:
- to the personal safety of the other party or to that of their loved ones (duress is duress)
- to the safety of the other party's goods or property (duress is duress)
- to the other party's economic or financial well-being, interest or economic status (duress is duress)

Unlawful influence

- If one party has influence over the other party and they take advantage of that influence such that the other party is not really exercising their independent judgment, the contract will be voidable on the grounds of undue influence (duress is duress).

Four classes of undue influence

- Unconscionable influence**
 - Some classes of relationships automatically give rise to the presumption of undue influence:
 - doctor and patient,
 - teacher and student,
 - trustee and beneficiary,
 - parent/guardian and child, or
 - religious leader and follower
 - The presumption can also arise where the relationship is one of confidence where the stronger party gives advice and guidance and is relied on by the weaker party. The stronger party knew the advice will be relied on. (duress is duress)

- When the presumption arises, it is then up to the other party to prove that there was no undue influence exerted.

Actual undue influence

- Actual undue influence is where the transaction was entered into as a result of actual undue influence.
- The party asserting undue influence must prove it must show that the influence was exerted at the time of entering into the contract and that it was undue (i.e. it was an unconscionable use of any special capacity or opportunity that may have existed on either side and that affected the weaker party's will or freedom of judgment).
- Circumstances that constitute duress can also

- After we have established whether a contract has been formed (consensus, agreement and communication) and all that, we can look at what the contract actually says – what is it that the parties have agreed to include in the contract – these are the terms of the contract.
- In the terms of the contract are the specific details of the agreement, including each party's rights and obligations.

Express terms

- Express terms are those terms explicitly agreed upon by the parties.
- There can be an oral or written or implied term.
- A term may be stated in a contract or verbally.
- If terms are not followed, they are said to be breached.
- Range in detail that a contract can be written, oral or a combination of both.
- How do you determine what are the terms of the contract?
- If the parties reduce their contract into writing, then the terms of the contract are what is written.
- But sometimes statements can be made by either parties, then those statements can be added to the terms of the contract.
- Not all statements made would be considered terms of the contract. Courts have made the following distinction:
 - Representation is term.
 - Term is term.

Representations

- These are statements of fact made by one party before or at the time of making a contract to induce an offeror to enter the contract.
- They are not regarded as terms, so they don't form part of the contract.

- These are considered to be more substantial than representations because they are more likely to be taken seriously by the other party.

Terms, conditions and warranties

- Whether a statement is a term of the contract or a representation that is not part of the contract depends on the intention of the parties.
- The Court applies an objective test (duress is duress)
- What would a reasonable person, aware of the circumstances of the case, believe to be the parties' intention in regard to the statement?
- The court will look at the following objective factors:

- A collateral contract is a secondary contract in which the representation or promise the other party has entered into that main contract (duress is duress)
- If the representation or promise is not part of the contract, the collateral contract (duress is duress)
- Where it is the collateral contract that is breached, not the main contract, the other party cannot terminate the main contract.
- Only entitled to damages for breach of collateral contract.

Exclusion clauses and disclaimer

- Exclusion clause is a statement or disclaimer that is not part of the contract.
- A disclaimer is a statement that a party will not be in breach despite having to perform and or meet its contractual obligations. They are used to limit or exclude liability for certain events.
- Examples: "No refunds", "Discontinued sale of food goods" (duress is duress)
- So, when a party is in breach of a law, they may try to rely on an exclusion clause to get out of trouble.
- Whether a disclaimer will effectively protect the party from liability for breach of contract depends on:
- The exclusion clause must be incorporated into part of the contract.
- The exclusion clause must be interpreted to be wide enough to cover the breach.
- The nature and extent of the exclusion clause must not have been unreasonable to the innocent party.
- The clause cannot exclude certain duties.

- The objective of the court is making an award of damages is to restore the other party to the position they would have been in if the breach or misrepresentation had not occurred, that is, if the contract has been performed properly.
- Exclusion clauses and disclaimer
- If the other party can demonstrate to the court that an award of damages is not a satisfactory remedy, the court may decide to provide an equitable remedy, such as:
- specific performance, or
- injunction.
- An order of specific performance
- A court order directing the party in breach to fulfil their contractual obligations (duress is duress)
- An injunction
- A court order forbidding someone from engaging in particular conduct that will be a breach of the law or infringe the legal rights of another (duress is duress)

Exclusion clauses and disclaimer

- The ACL is primarily concerned with protecting the interests of consumers against unfair practices of traders and providing adequate remedies to consumers where there is a breach of the ACL.
- The ACL protects consumers against:
- unconscionable conduct.
- misleading or deceptive conduct.
- unfair contract terms.
- The ACL also has been given consumer rights which buying goods and services, establishes product safety laws and information standards, establishes product liability and establishes manufacturer's liability for defective goods.

Unconscionable conduct

- Unconscionable conduct is a person must not, in trade or commerce, engage in conduct that is misleading or deceptive or is likely to mislead or deceive.
- Section 51 of the ACL requires conduct to be unconscionable.
- A person who suffers loss because a business has contravened s51 can commence legal proceedings against the business and seek one or more of the wide range of remedies offered by the ACL.
- The range of remedies provided by the ACL is much wider than that available in common law for misrepresentation or breach of contract.
