**Dilation - correct answer** A transformation that preserves angle measures and results in an image with lengths proportional to the premiere lengths.

**Similar Polygons - correct answer** Two polygons such that their corresponding angles are congruent and the lengths of corresponding sides are proportional

**Center of Dilation - correct answer** In a dilation, the fixed point about which the figure is enlarged or reduced.

**Scale Factor of Dilation - correct answer** In a dilation, the ration of a side length of the image to the corresponding side length of the original figure.

**Scale Factor of two similar polygons - correct answer** The ratio of the lengths of two corresponding sides of two similar polygons.

**Center of Dilation - correct answer** In a dilation, the fixed point about which the figure is enlarged or reduced

**Reduction - correct answer** A dilation with a scale factor between 0 and 1

**Enlargement - correct answer** A dilation with a scale factor greater than 1

**Pythagorean triple - correct answer** A set of three positive integers a, b, and c that satisfy the equation  $c^2 = a^2 + b^2$

**Trigonometric Ratio - correct answer** A ratio of the lengths of two sides in a right triangle.

**Tangent - correct answer** A trigonometric ratio, abbreviated as tan. For a right triangle ABC, the tangent of the acute angle A is TOA (leg opposite/leg adjacent).

**Sine - correct answer** A trigonometric ratio, abbreviated as sin. For a right triangle ABC, the sine of the acute angle A is SOH (leg opposite/hypotenuse).

**Cosine - correct answer** A trigonometric ratio, abbreviated as cos. For a right triangle ABC, the cosine of the acute angle A is CAH (leg adjacent/hypotenuse).

**Angle of Elevation - correct answer** When you look up at an object, the angle that your line of sight makes with a line drawn horizontally.

**Angle of Depression - correct answer** When you look down at an object, the angle that your line of sight makes with a line drawn horizontally.
